

## Early Learning Centre Fees 2018

Effective 1 January 2018

### Enrolment Application Fee - \$60 Enrolment Acceptance Bond - \$300

ELC offers preschool program and long day care for 5 days per week, or 5 days per fortnight. The 5 days per fortnight alternates as 3 days one week and 2 days the next week.

### Pre-School Program (8:15am – 2:30pm) 3 and 4 year olds

5 days per week	\$360 per week
5 days per fortnight	\$360 per fortnight*

### Pre-School Program with before and after Pre-school Care (7:00am – 5:30pm) 3 and 4 year olds

5 days per week	\$460 per week
5 days per fortnight	\$460 per fortnight*

\*Pre-School Program is billed at \$72 per day and Pre-School Program with before and after Pre-school Care is billed at \$92 per day. Fees are billed weekly in arrears and are net of any rebates and benefits which will be paid directly to the ELC. Fees are charged for booked hours and any time over those agreed hours.

**Late/Early Fee** \$1 per minute late pickup/early drop off (greater than 5 minutes)

These fees do not take into account Child Care Benefit and Child Care Rebate payments refunded through Centrelink.

### Allowable Absences

Child Care Rebate is paid for up to 42 absences per child each financial year. A public holiday is counted as an absence if the child normally attends on that week day, and fees are charged for that day for the child. ### Childcare Subsidy

### Leave and Holding fees

A holding fee of 50% is charged for periods of notified extended leave greater than 5 consecutive days including family holidays and sickness.

### Account in Good Standing

An account is in 'good standing' when Early Learning Centre fees are paid in full within 7 days of the account being issued. Failure to do so may result in a student being precluded from attending. Payment may be made by Cash, EFTPOS, Credit Card or EFT BSB 704-942 Account 152880 in name of GSLC SACL ELC. Please use your Family Reference Key.

### Notice period

Two weeks' notice is required, if you are cancelling or reducing the care for your child.
